RESOLUTION 2025-206

AUTHORIZING THE DISPOSITION OR SALVAGE OF VEHICLES AND EQUIPMENT IN THE POSSESSION OF THE BOROUGH AT AUCTION ON GOVDEALS.COM AND OTHER DISPOSAL IN ACCORDANCE WITH N.J.S.A. 40A:11-36

WHEREAS, the Borough Police Department has requested that the Borough Council authorize the disposition of Vehicles and Equipment currently in the possession of Bradley Beach Borough and also request to salvage the equipment should the asking price and second offer be rejected; and,

WHEREAS, property not exceeding 15% of the bid threshold shall be disposed of in accordance with N.J.S.A. 40A:11-36(1); and

WHEREAS, such surplus items may be sold at public auction to the highest bidder in accordance with N.J.S.A. 40A:11-36; and

WHEREAS, the Borough Council has reviewed a request which describes the items aforesaid to be sold at the auction; and

WHEREAS, the following equipment shall be sold at auction on Govdeals.com to the highest bidder:

- **Items of jewelry**
- **Bicycles and/or electric bicycles, skateboards, or any other riding equipment**
- **Scooters**
- **Any unused police equipment of value including but not limited to (2) T3 Series Electric Stand-Up Vehicle (similar to segways)**

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Bradley Beach, County of Monmouth, State of New Jersey, as follows:

- 1. That the Division of Purchasing, or its designee, be and hereby is authorized to sell at auction to the highest bidder, any and all surplus items as described.**
- 2. The sale of the surplus property shall be conducted through Govdeals in accordance with the terms and conditions as attached: and**
- 3. The sale will be conducted online, and the address of the auction site is www.Govdeals.com.**
- 4. The sale is being conducted pursuant to Local Finance Notice 2019-15.**
- 5. The surplus property as identified shall be sold in an “as-is” condition without express or implied warranties with the successful bidder required to execute a Hold Harmless and Indemnification Agreement concerning use of said surplus property.**
- 6. The Borough reserves the right to accept or reject any bid submitted. That the Division of Purchasing, or its designee, be and hereby is authorized to sell at auction to the highest bidder, any and all surplus items as described.**
- 7. That a certified copy of this Resolution shall be forwarded to the following:**

 - C. The Qualified Purchasing Agent**
