**RESOLUTION AUTHORIZING THE SETTLEMENT OF PENDING LITIGATION
BEFORE THE SUPERIOR COURT OF NEW JERSEY, MONMOUTH COUNTY
ENTITLED HINGSTON v. BOROUGH OF BRADLEY BEACH,
DOCKET NO. MON-L-3790-24**

Mayor Gubitosi offered the following Resolution and moved its adoption:

WHEREAS, on or about November 12, 2024, a Complaint was filed against the Borough of Bradley Beach, County of Monmouth, State of New Jersey (the "Borough") by Bradley Beach Police Officer Christopher Hingston, entitled *Hingston v. Borough of Bradley Beach – Docket No. MON-L-3790-24* (the "Action"), wherein it is alleged that the Borough's prior administration failed to pay required military pay differential to plaintiff-employee, and further failed to provide certain benefits to plaintiff-employee, in violation of law; and

WHEREAS, the Borough denied the allegations and claims made in the Action; and

WHEREAS, the Borough's current administration finds it to be in the best interests of the taxpayers of the Borough and the plaintiff-employee that the Action be fully and finally settled;

WHEREAS, the Chief Financial Officer has reviewed the Settlement Agreement and determined that the proposed back-payment of plaintiff-employee's military differential pay is true and accurate, and has issued a Certificate of Available Funds therefor;

NOW, THEREFORE, BE IT RESOLVED, that the Governing Body of the Borough of Bradley Beach, County of Monmouth, State of New Jersey, hereby authorizes the full and final settlement of *Hingston v. Borough of Bradley Beach – Docket No. MON-L-3790-24*, and directs the Borough Administrator to execute the Settlement Agreement and in accordance therewith, make the back-payment of military differential pay pursuant thereto; and


