**AUTHORIZING PROCUREMENT OF VEHICLES AND ACCESSORIES THROUGH NEW JERSEY STATE CONTRACT 23-FLEET-34933, PURSUANT TO NEW JERSEY STATE CONTRACT DIVISION OF PURCHASE AND PROPERTY.**

**WHEREAS**, a need exists for the acquisition of a 2024 Dodge Durango (WDEE75) Pursuit AWD patrol vehicle through the New Jersey Division of Purchase and Property state contract #23-Fleet-34933, for the daily operations of the Borough of Bradley Beach Police Department; and
