**RESOLUTION AUTHORIZING THE SETTLEMENT OF PENDING LITIGATION
BEFORE THE SUPERIOR COURT OF NEW JERSEY, MONMOUTH COUNTY
ENTITLED HALL v. BOROUGH OF BRADLEY BEACH,
DOCKET NO. MON-L-2713-24**

Mayor Gubitosi offered the following Resolution and moved its adoption:

WHEREAS, on or about August 14, 2024, a Complaint was filed against the Borough of Bradley Beach (the “Borough”), entitled *Hall v. Bradley Beach – Docket No. MON-L-2713-24* (the “Action”), wherein plaintiff-employee alleged that the Borough’s prior administration violated the Conscientious Employee Protection Act, created a hostile work environment, and failed to provide certain employment benefits to plaintiff-employee in violation of law; and

WHEREAS, the Borough denied the allegations and claims made in the Action; and

WHEREAS, the Borough’s current administration finds it to be in the best interests of the Borough that the Action be fully and finally settled by making payment to plaintiff-employee in the amount of \$55,000.00; and

WHEREAS, the Monmouth County Municipal Joint Insurance Fund is financially responsible for the Action, except for the Borough’s \$2,500.00 deductible;

NOW, THEREFORE, BE IT RESOLVED, that the Governing Body of the Borough of Bradley Beach, County of Monmouth, State of New Jersey, hereby authorizes the full and final settlement of *Hall v. Borough of Bradley Beach – Docket No. MON-L-2713-24*, by paying to plaintiff-employee the amount of \$55,000.00, and hereby directs the Borough Administrator and Borough Attorney to administratively execute said settlement; and

BE IT FURTHER RESOLVED that a copy of this Resolution shall be forwarded to the Borough Administrator, Borough Attorney, and the Monmouth County Municipal JIF.
