RESOLUTION 2025-285

**ADOPTING AN UPDATED AND NEW EMERGENCY OPERATIONS PLAN (EOP)
AND AMONMOUTH COUNTY INTRA-COUNTY
MUTUAL AID AND ASSISTANCE AGREEMENT (MAA)**

WHEREAS, Chapter 222, Public Law 1989 mandates the development and approval of Emergency Operations Plans for all Municipalities, Counties, and the State; and

WHEREAS, an Emergency Operations Plan will allow the Municipality in correlation with the Municipal Office of Emergency Management to better prepare and manage jurisdiction-wide emergencies; and

WHEREAS, the Borough of Bradley Beach must submit an Emergency Operations Plan through the County Office of Emergency Management to the State Office of Emergency Management for initial review and approval, and will require certification every two (2) years; and

WHEREAS, the Mayor and Council of the Borough of Bradley Beach are in receipt of an Emergency Operations Plan and a request from the Bradley Beach Office of Emergency Management for formal adoption; and

WHEREAS, on May 24, 2023, the Mayor and Council adopted Resolution 2023-171 authorizing the execution of the Monmouth County Intra-County Mutual Aid and Assistance Agreement between the County, the Borough of Bradley Beach, and Participating Units.

NOW THEREFORE BE IT RESOLVED, by the Mayor and Council of the Borough of Bradley Beach Emergency Operations Plan be and is hereby adopted.

BE IT FURTHER RESOLVED, that the Mayor and Council of the Borough of Bradley Beach hereby authorizing the continual participation in the Monmouth County Intra-County Mutual Aid and Assistance Agreement as referenced for the term consistent with the Municipal Emergency Operations Plan.

BE IT FURTHER RESOLVED, that the Municipal Clerk forwards a certified true copy of this resolution to the Monmouth County Office of Emergency Management Coordinator.
