RESOLUTION 2025-49

**ADOPTING THE TEMPORARY OPERATING BUDGET FOR THE YEAR 2025
INCLUSIVE OF THE TEMPORARY DEBT SERVICE BUDGET FOR 2025.**

WHEREAS, N.J.S.A. 40A:4-19 provides that where any contract, commitment or payments are to be made prior to the final adoption of the annual municipal budget, temporary appropriations should be made for the purpose and amounts required in the manner and time therein provided; and

WHEREAS, as required by said statute, this resolution is adopted during the first thirty (30) days of the 2025 fiscal year; and

WHEREAS, the total amount of the appropriations attached hereto (SCHEDULE A) and made a part thereof in the amount of \$3,104,809.00 for the Current Fund, \$654,703 for the Sewer Utility Operating Fund and \$814,954 for the Beach Utility Operating Fund does not exceed twenty-six and one-quarter percent (26.25%) of the Budget Appropriations of the Borough of Bradley Beach for the year 2024, exclusive of any 2024 appropriations made for debt service charges, capital improvement fund, and public assistance and exclusive of 2025 Debt Service Appropriations.

WHEREAS, the temporary operating budget for 2025 shall not exceed 26.25% of the total appropriations in the 2024 budget exclusive of any appropriations made for interest and debt redemption charges, capital improvement fund, and public assistance. Therefore the temporary budget appropriations for 2025 shall not exceed the following:

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Bradley Beach in the County of Monmouth, State of New Jersey, that the attached 2025 Temporary Operating Budgets for the Current Fund, Sewer Utility, and Beach Utility are hereby adopted.

BE IT FURTHER RESOLVED THAT a certified copy of said Resolution be forwarded to the Chief Financial Officer.
