**RESOLUTION APPROVING A FAIR AND OPEN PROFESSIONAL SERVICES  
CONTRACT WITH RUDERMAN & ROTH AS BOROUGH LABOR ATTORNEY.**

**Mayor Gubitosi** offered the following Resolution and moved its adoption:

**WHEREAS**, the Borough of Bradley Beach (the “Borough”), requires the services of a Borough Labor Attorney; and

**WHEREAS**, after a fair-and-open process that advertised a request for proposals for professional services to fulfill said vacant position for the calendar year 2025, on January 1, 2025, the Borough duly appointed Ruderman & Roth as Borough Labor Attorney; and

**WHEREAS**, upon their appointment, Ruderman & Roth provided the Borough with a Proposal for their professional services in the amount of \$175.00 per hour; and

**WHEREAS**, the Chief Financial Officer has issued a Certificate of Available Funds which is incorporated herein by reference;

**NOW, THEREFORE, BE IT RESOLVED**, by the Borough Council of the Borough of Bradley Beach, County of Monmouth, State of New Jersey, that:

- 1.** The Mayor and/or Administrator are authorized to enter into a professional services contract with Ruderman & Roth to serve as Borough Labor Attorney pursuant to the terms of the Proposal.
- 2.** The engagement of Ruderman & Roth is exempt from public bidding as a professional service under N.J.S.A. 40A:11-5.1(a)(i), and is being awarded under a “fair and open” process in accordance with New Jersey’ Pay-to-Play Law.
- 3.** Notice of this Resolution shall be published in the designated official newspapers as required by law within ten (10) days of the passage of this Resolution.
- 4.** A certified copy of this Resolution be forwarded to the Borough Administrator, Borough CFO, and Ruderman & Roth.
