AUTHORIZING AMENDMENTS TO THE TEMPORARY BUDGET

WHEREAS, an emergency condition has arisen with respect to the fact that the Township has yet to adopt its 2026 budget and no adequate provision has been made in the 2026 temporary appropriations for the aforesaid purpose, and N.J.S.A. 40A: 4-20 provides for the creation of an emergency temporary appropriation for the above mentioned; and,

WHEREAS, the total emergency temporary resolutions adopted in the year 2026 pursuant to the provisions of Chapter 96, P.L. 1951 (N.J.S.A. 40A: 4-20) including this resolution total \$8,182,141.00; and,

NOW, THEREFORE, BE IT RESOLVED, (by not less than two-thirds of all the members thereof affirmatively concurring) by the Governing Body of the Borough of Bradley Beach, County of Monmouth, State of New Jersey, that in accordance with the provisions of N.J.S.A. 40A:4-20;
