WHEREAS, the Borough of Bradley Beach may by resolution, and without advertising for bids or obtaining quotations, purchase any goods or services as per N.J.S.A. 40A:11-11, under the Educational Services Commission of New Jersey Cooperative Pricing System; and

WHEREAS, the Bradley Beach Borough has the need on a timely basis for a Kubota SVL97-3HFCC Compact Track Loader with Hydraulic Angle Broom and Pallet Fork Frame utilizing Educational Service Commission of New Jersey Contracts, duly authorized under law to extend contract pricing to local units, per N.J.A.C. 5:34-7 et. Seq.; and

WHEREAS, Cherry Valley Tractor Sales, is the holder of "ESCNJ 22/23-12 ", expiring August 31, 2026; and

WHEREAS, Cherry Valley Tractor Sales, has provided for a quote under the cooperative in the amount of \$97,595.65 for a Kubota SVL97-3HFCC Compact Track Loader with Hydraulic Angle Broom and Pallet Fork Frame; and
