RESOLUTION 2026-125

**AUTHORIZING THE EXECUTION OF A \$2,000,000 GRANT AGREEMENT
WITH THE STATE OF NEW JERSEY DEPARTMENT OF ENVIRONMENTAL
PROTECTION FOR THE BOROUGH'S SANITARY SEWER INFRASTRUCTURE
REPLACEMENT PROGRAM**

WHEREAS, the Borough of Bradley Beach has a need to upgrade the aging sanitary sewer infrastructure within the Borough through the replacement of existing sanitary sewers and the installation of new sanitary sewers; and

WHEREAS, Suburban Consulting Engineers, Inc. was previously authorized to perform grant application services in support of a Technical Assistance Grant from the New Jersey Department of Environmental Protection (NJDEP) in order to help fund these improvements; and

WHEREAS, the Borough of Bradley Beach successfully submitted a grant application to the NJDEP for \$2,000,000 to fund the planning and design efforts for the sanitary sewer improvements; and

WHEREAS, the Borough of Bradley Beach was awarded the grant in the amount of \$2,000,000 and hereby accepts said grant allotment; and

WHEREAS, the Borough of Bradley Beach desires to further the public interest by entering into a grant agreement with the State of New Jersey in the amount of \$2,000,000 to fund the planning and design of these sanitary sewer improvements; and

WHEREAS, the Borough designates Matthew Doherty, Business Administrator, or the successor to said office as the Borough's Authorized Representative to execute an agreement with the NJDEP and administer the grant in an amount not less than \$0.00 and not more than \$2,000,000.00;

NOW, THEREFORE, BE IT RESOLVED, that the Governing Body of the Borough of Bradley Beach, County of Monmouth, State of New Jersey hereby authorizes the execution of a grant agreement with the NJDEP on behalf of the Borough for the funding of \$2,000,000 in planning and design services for the Borough's Sanitary Sewer Infrastructure Program, with a 0% match of the total project amount by the Borough, in compliance with the match requirements of the agreement prepared by the NJDEP, and the Borough agrees to comply with all applicable federal, State, and municipal laws, rules, and regulations in its performance of the work associated with this agreement.
