WHEREAS, the Borough of Bradley Beach is in need of improvements to Sylvan Lake Bulkhead; and

WHEREAS, the Borough sought bids in accordance with N.J.S.A. 40A:11-4a; and

WHEREAS, the procurement was conducted in a fair and open manner in accordance with N.J.S.A. 19:44A-20.5; and

WHEREAS, six (6) bids were received as follows:

Contract for Goods and Services reference herein and made a part of this award of contract as well as any non-substantive modifications thereto and related constituent documents.

3. The Municipal Clerk is directed to forward a certified copy of this Resolution to the Qualified Purchasing Agent, Chief Financial Officer, Borough Engineer, Borough Attorney and Earthworks, Inc.
