RESOLUTION 2026-181

RESOLUTION GRANTING PERMISSION FOR D'ARCY'S TAVERN TO OPERATE OUTDOOR TELEVISIONS UNTIL 12:30AM OR UNTIL FIFTEEN MINUTES AFTER THE UNITED STATES' WORLD CUP GAME ON THURSDAY, JUNE 25, 2026

Councilman Karp offered the following Resolution and moved its adoption:

WHEREAS, given the special and historic hosting of the FIFA World Cup in the United States and North America this month, D'Arcy's Tavern requested special permission from the Borough of Bradley Beach (the "Borough") to continue operating its outdoor televisions to accommodate patrons watching the United States game on Thursday, June 25, 2026, beginning at 10:00 p.m., which is the ordinary cutoff time for its outdoor televisions; and

WHEREAS, D'Arcy's Tavern requested to operate its outdoor televisions until 12:30 a.m. on Thursday, June 25, 2026 for the late-scheduled United States game that night; and

WHEREAS, the Borough Council finds it to be in the best interests for D'Arcy's Tavern to be permitted to operate its outdoor televisions until 12:30 a.m. on Thursday, June 25, 2026, or until fifteen minutes after the conclusion of the United States World Cup game on Thursday, June 25, 2026, whichever occurs last;

NOW, THEREFORE, BE IT RESOLVED, that the Governing Body of the Borough of Bradley Beach, County of Monmouth, State of New Jersey, approve D'Arcy's Tavern to operate its outdoor televisions until 12:30 a.m. on Thursday, June 25, 2026, or until fifteen minutes after the conclusion of the United States World Cup game on Thursday, June 25, 2026, whichever occurs last; and

BE IT FURTHER RESOLVED that a copy of this Resolution shall be forwarded to the Borough Administrator, DPW Director, and Police Chief.
