**APPROVAL TO APPLY FOR A \$250,000.00 GRANT
THROUGH THE DEPARTMENT OF HUMAN SERVICES (DHS)
TO SUPPORT A SENIOR WELLNESS PROGRAM**

WHEREAS the Governing Body of the Borough of Bradley Beach, County of Monmouth desires to apply for a grant in support of a project "Senior Socialization & Mobility Pilot proposed by the New Jersey Department of Human Services (DHS); and

WHEREAS, the Borough of Bradley Beach, County of Monmouth intends to apply for grant money for the following items and in the following amounts:

1. ADA Transportation	\$96,000.00
2. ADA Expansion Days	\$36,000.00
3. Monthly Day Trips	\$60,000.00
4. Enrichment Programs	\$28,000.00
5. Luncheons/Food	\$14,000.00
6. Evaluation & Reporting	\$12,000.00
7. Fuel Rate Contingency	\$4,000.00

Total: \$250,000.00

NOW THEREFORE BE IT RESOLVED that the Governing Body of the Borough of Bradley Beach, County of Monmouth does hereby authorize the application for the above grant; and

BE IT FURTHER RESOLVED that the Borough of Bradley Beach, County of Monmouth recognizes and accepts that the DHS may offer a lesser or greater amount of grant funding than that requested; and

BE IT FURTHER RESOLVED that the Governing Body of the Borough of Bradley Beach, County of Monmouth authorizes the execution of the grant agreement in the amount offered and approved by DHS and further authorizes the expenditure of funds pursuant to the terms of the grant agreement entered into by the Borough of Bradley Beach and the DHS; and

BE IT FURTHER RESOLVED that the Borough of Bradley Beach agrees to comply with all regulations and guidelines and accepts that the proposed use of funds are not reimbursable by other federal agencies; and

BE IT FURTHER RESOLVED the persons whose names appear below (or any successor or assign) are authorized to sign the grant agreement or any other document in connection therewith.
