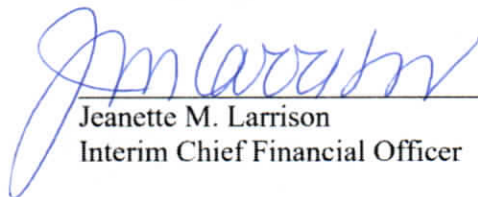

1. 5. The Borough shall also provide notice that these appointments are being awarded under a non-fair and open process in accordance with New Jersey's Pay-to-Play law.
6. **Sarah Aubrey, of The Aubrey Group, LLC** shall submit a Business Entity Disclosure Certification which certifies compliance with New Jersey's Pay-to-Play law; and
